BOARD OF DIRECTORS OF ELICA S.P.A. APPROVES AMENDMENT TO SHARE OPTION AGREEMENT WITH WHIRLPOOL

Fabriano, 15 June 2009 – The Board of Directors of Elica S.p.A., the parent company of a Group that is the leading manufacturer of kitchen range hoods, today approved the amendment to the Share Option Agreement signed on 10 December 2007 with Whirlpool.

The amendment to the Agreement concerns the extension of the exercise period of the call option on Elica shares until 31 December 2009; in addition, Whirlpool, in the same period, will have the option to purchase up to 3% of Elica shares on the market, with Elica having the right to receive Euro 0.50 for each share bought and the maximum limit of the total Whirlpool holding of 15% of Elica shares, deriving from the Option Agreement.

The modification of the agreement is due to the persistence of the exceptional macro-economic conditions which have affected its fulfilment in accordance the will of the individual parties.

Detailed information regarding the Shareholder Agreements will be communicated through the publication of the extract of the Agreements in the manner and within the time limits established by article 122 of Legislative Decree No. 58/1998.

The **Elica Group** has been present in the cooker hood market since the 1970s and is today world leader in terms of units sold. It is also a European leader in the design, manufacture and sale of motors for central heating boilers for domestic use.
