#### **ELICA TREASURY SHARE BUYBACK INFORMATION**

Fabriano, June 19, 2023 – Elica S.p.A, ("Elica" or the "Company") following the announcement on April 27, 2023 regarding the start of the share buyback program, in execution of the April 27, 2023 Shareholders' Meeting resolution - informs that during the period June 5 - 13 2023 it has purchased n. 8,485 treasury shares at an weighted average price of Euro 2,67 per share, for a total amount of Euro 22,674.

Below, on the basis of the information provided by the intermediary appointed to carry out the purchases, the daily transaction details of the purchase of Elica ordinary shares carried out on the Euronext STAR regulated market of the Italian Stock Exchange in the aforementioned period are reported:

Since the start of the program, ELICA has purchased no 778,350 ordinary shares (equal to 1.23% of the share capital), for a total value of Euro 2,289,799.

Following the purchases made so far, Elica holds a total of no. 778,350 treasury shares, equal to 1.23% of the share capital.
