#### ELICA TREASURY SHARE BUYBACK INFORMATION

Fabriano, July 11, 2022 – Elica S.p.A, ("Elica" or the "Company") following the announcement on March 16, 2022 regarding the start of the share buyback program, in execution of the April 28, 2022 Shareholders' Meeting resolution - informs that during the period July 4-7, 2022 it has purchased n. 7,461 treasury shares at an weighted average price of Euro 2.75 per share, for a total amount of Euro 20,548.

Below, on the basis of the information provided by the intermediary appointed to carry out the purchases, the daily transaction details of the purchase of Elica ordinary shares carried out on the lon the Euronext STAR regulated market of the Italian Stock Exchange in the aforementioned period are reported:

Since the start of the program, ELICA has purchased no. 325,000 ordinary shares (equal to 0.51% of the share capital), for a total value of Euro 1,010,780.

Following the purchases made so far, Elica holds a total of no. 325,000 treasury shares, equal to 0.51% of the share capital.
