Due to the passing of Gianna Pieralisi, holder of 33,608,690 ordinary Elica S.p.A. shares, her son Francesco Casoli - Chairman of Elica S.p.A. since 2006 and currently in office – ope legis becomes the controlling shareholder of FAN S.r.l. and therefore of Elica S.p.A., as holder of some of the bare ownership rights stemming from the above-stated usufruct rights.

The Casoli Family will continue to be long-term shareholders of Elica, supporting the strategy of continual expansion and development in place.
